## Program Overview

Chimney Rock Golf Course has recently been given the ability to offer a new program that helps to raise funds for non-profit organizations in and around Bayard. Through our “Benefit Night Program”, non-profit organizations can fundraise by becoming celebrity servers. Members of non-profit organizations will help by taking orders, serving food, and help with the clean-up. Groups that participate in this program will be given 15% of the total sales from 5:00 PM to 8:00 PM. In addition to this, the organization will be able to collect tips and any other donations from supporters.

## Do you qualify?

To qualify for our Benefit Night Program you must fit the following criteria:

- Must be a non-profit organization.
- Must benefit Bayard or surrounding community.
- Cannot be for an individual(s).
- Cannot execute more than one benefit night in a single month.

## How it works

**Step 1:** Read through this pamphlet to determine if your organization qualifies to take part in our Benefit Night Program and to understand how our program works.

**Step 2:** If you qualify, fill out an application; found on the pamphlet and turn in to the City of Bayard or Chimney Rock Golf Course.

**Step 3:** When contacted by a manager of Chimney Rock Golf Course, a determination meeting will be held for the following reasons: to determine if your organization can fulfill their obligations of a benefit night, to conduct an orientation of the program, to answer questions if your organization should have any.

**Step 4:** At this point your organization will be presented with several dates that are available to schedule a benefit night. Your organization may choose one of the dates presented. Congratulations, your organization is now on our Benefit Night Program calendar.

## You organization's commitment

The following commitments must be made by your organization in order to participate in our Benefit Night Program:

- Commit to one meeting with a manager of Chimney Rock Golf Course.
- Be able to participate for three (3) hours in a benefit night event, 5pm to 8pm.
- Have at least five (5) members of your organization present at all times during the duration of your scheduled benefit night.
- Be able to wipe tables, carry out meals and beverages, assist in clean-up; represent your organization in a professional manner (through your community service); and represent Chimney Rock Golf Course in a positive manner (through customer service).
- You and your five (5) members attend an orientation meeting fifteen (15) minutes before your benefit night takes place on the day of (4:45pm).
- Advertise internally (to your group and members of your organization) and externally (to others outside your group), at your ability.
