

## BAYARD CITY POOL

City of Bayard Pool Staff welcomes you to our pool. In order for you and/or your child to use the pool facilities the following regulations and release must be read and completed. It is important that you discuss the rules and regulations concerning pool use with your children and that you impress upon them the importance of the following rules and regulations. We would ask that you have a plan for picking up your child from the pool in case the pool is closed because of inclement weather. The safety of you and your child is our first and foremost concern. We hope you enjoy your visit us. Have a fun and safe summer.

### POOL REGULATIONS

- No person is permitted to use the pool without first having taken a warm water shower, using soap.
- No person having an obvious communicable disease, skin eruption, cut, sore, or lesion, eye, ear, nose, or throat infection, is permitted to use any public swimming pool.
- Spitting or spouting of water, blowing the nose, or any other similar activities in the swimming pool is strictly prohibited.
- No running, boisterous or rough play, except supervised water sports, is permitted in the pool, or on the runways, diving boards, floats, platforms, or in the dressing rooms.
- No person may take food or drink inside the pool enclosure.
- Dogs and other animals are not allowed in the pool area.
- All children under 5 years of age and non-swimmers must be accompanied by a parent or responsible adult supervision.
- The management reserves the right to refuse admittance or eject from the pool premises, any person failing to comply with any of the above health and safety regulations.

### WAIVER OF RELEASE OF LIABILITY

I, the undersigned, parent/guardian of the persons listed below hereby grant permission for them to enter the various activities of the City of Bayard, Nebraska and the City of Bayard Youth and Adult Recreation Department Program and to participate in these activities and I assume all risks of injury or death to my child/ward that may be sustained in connection with the stated and associated activities in and about the premises.

In consideration of the permission granted to my child/ward to enter the premises and participate in the stated activities, I hereby, for myself, my heirs, administrators and assigns release, and discharge the owners, operator's and sponsors of the premises and activity and the City of Bayard and their respective servants, agents, officers, and officials and all other participants in the stated activities of and from all claims, demands, actions and causes of action of any sort, for injury or death sustained to my child/ward during my child's/ward's participation in the stated activities due to negligence or any other fault.
